

JULY 2022 NACR QUARTERLY REPORT ON GENDER AND MARITAL STATUS (RE-RUN USING JAN 2023 DATA DOWNLOAD)

(Jan to Mar 2022 data; patient records were included if they had their initiating event date within the time period and sufficient data - more than 10 Initiating Events created - within the named programme)

This is the fourth Quarterly Report for NACR in which the audit continues to detail the demographic characteristics of patients both prior to and starting Core/Phase 3 cardiac rehabilitation (CR) at a local service level for England, Northern Ireland and Wales. The report uses 'pseudo-eligible' – i.e. patients with an initiating event recorded on NACR between January and March 2022.

This report is showcasing the level of uptake in programmes for two demographic factors, shown in wider research to influence the participation rate of CR. The table splits the patient group within the programme into gender - male and female - and within these by marital status. Marital status is a six-category variable on the database that, for the purpose of this report, has been grouped into Single, Partnered (Married or Permanent Partnership) and Previous Partner (Divorced, Widowed and Separated). In previous research, performed by NACR, gender and marital status have shown a strong association with participation.

This report shows the local variation in participation of known groups who experience inequality in CR access. There was a wide spread of participation, which may be affected by small sample size. However, trends seen are:

1. The Male group have the highest average uptake in the partnered group (64%) followed closely by previous partnered (60%), whereas the male single group was the lowest (58%).
2. The female averages were similar to that of the males: the lowest participation group was single patients (57%) and having a partner was shown to be 6% points higher than previous partnered (Partnered 58% and Previous Partnered 64%).

NB: This data should not be used as an indicator of service level uptake as the total number of eligible patients could not be verified due to Covid-19 service pressures.
